COVID vaccine at Health Unit

The West Baton Rouge Parish Health Unit has applied to be a distributor of the COVID-19 vaccine. Once the vaccine is received from the Louisiana Department of Health (LDH), residents will be notified via the parish's website and social media platforms and news media, and a contact number to schedule an appointment for the vaccine shot will be provided.

According to present LDH guidelines, only those age 70 and older are presently being allowed to have the vaccine. Proper identification will be required by the Health Unit. A waiting list will not be taken at the Health Unit. Appointments will be made on a first-come, first-served basis of those calling in once the Health Unit is allowed to open the process by LDH.

Walgreens in Port Allen and Wal-Mart are also approved by LDH as sites for distribution of the COVID-19 vaccine in WBR.

Three major economic development projects heading to West Baton Rouge

Three industrial projects proposed for West Baton Rouge could pump billions into the economy, and will produce hundreds of jobs over the coming decade.

GRON FUELS:

The biggest project, by far, is the Grön Fuels bio-fuel plant proposed for property owned by the Port of Greater Baton Rouge near Port Allen. The first phase of construction would involve a capital investment of over \$1.25 billion and create 340 new direct jobs by 2024. The base project is expected to produce up to 60,000 barrels per day of low-carbon renewable diesel, with an option to produce renewable jet fuel utilizing non-fossil feedstocks, including soybean oil, corn oil and animal fats.

With expansions and associated projects, the complex could involve up to \$9.2 billion of total investment over several phases. Through all phases and associated projects, the complex would create an estimated 1,025 new direct jobs, with an average annual salary of \$98,595, plus benefits. "The port is excited to have finalized the ground lease and assist in advancing the investment in the Grön Fuels new renewable diesel project for Louisiana and the Greater Baton Rouge region," said Jay Hardman, Executive Director of the Port of Greater Baton Rouge.

"One of the exciting parts of this project is that Grön will build a new sewer treatment plant and the parish will be allowed to tie into this plant at no expense to the parish," said Parish President Riley "PeeWee" Berthelot. "This will provide the parish with the sewer treatment

infrastructure to accommodate growth for years to come. Grön has applied for its permits and we hope the project will move forward by the end of 2021."


AIR LIQUIDE:

A 15-acre undeveloped site off La. Hwy. 1 near Port Allen was sold to Air Liquide in December for a \$270 million expansion of its operations in the parish. The property was purchased for \$2.3 million. The land was part of the Poplar Grove Plantation. Air Liquide is planning the expansion of its facility in order to supply nitrogen and oxygen to Methanex's methanol plant under construction in Geismar.

AMAZON:

Land developer Seefried, which has ties with online retailer Amazon, has purchased a 63.3-acre site off La. Hwy. 415 for \$8.15 million, and filed a notice of the lease agreement with Amazon. A sorting facility, which is projected to provide 300 jobs, is expected to be constructed at the site.

Stay tuned for more developments to come on these and other projects.





Appeals Court rules for parish on levee walking/biking trail

A Louisiana appeals court has ruled in favor of West Baton Rouge Parish, granting the West Baton Rouge Parish Council a permanent injunction against landowners to prevent them from interfering with the bicycle path and walkway on top of the Mississippi River levee.

The parish began the extensive levee trail project in 2016, and several landowners filed suit in 2017, claiming that the levee top was their private property and construction of the walking and biking path was a violation of their property rights.

The trial court ruled in favor of the parish in 2018, noting that the use of the levee top for a walking and biking trail is constitutional and does not constitute taking of the landowners' property. It further prohibited the landowners from constructing anything to interfere with or delay the construction of the levee top path, or the obstruct the completed path.

The First Circuit Court of Appeals issued its ruling on January 11, 2021, in which it affirmed the trial court's ruling.

Utilities Director Keowen retires, Genre takes position



West Baton Rouge Utilities Director Pam Keowen, who has worked in the Utilities Department for 37 years, retired at the end of January. She had moved up in the department through the years after being hired on as a clerk in 1984. She worked in accounting and as office manager before being appointed Director when former Director Daryl "Turf" Babin retired in 2017.

Among many significant improvements made in the Utilities Department operations and infrastructure over the 37 years include:

- consolidating Addis Water District #1, Brusly District #2, and District #4 in the northern part of the parish under the Parish Utilities Department;
- the gas line construction installation under the Intracoastal Canal;
- establishing a computer mapping system for all infrastructure lines
- a gas tap on St. Romain Road;
- and the Genesis project. She noted that Babin led the Genesis project and gas tap on St. Romain Road - both major projects;
- construction of a new 20-inch water line to serve the southern part of the parish and water well; and
- a new software billing system.

Office Manager Monica Batiste retired in December. She had been with the Parish for 30 years. Adrian Genre was hired to take the Utilities Director position in 2020, and has been training under Keowen for almost a year, while she was completing the installation and implementation of the new billing software.

S. Riverview road rehab project to begin

A project to repair a portion of South Riverview Road is expected to begin within a month. The \$93,000 project to remove the existing road, located off Hwy. 190, and replace it with a new concrete road will be performed by Industrial Enterprises. The road is a heavily used industrial roadway. The parish's annual road improvement project for 2021 will be bid out later this year, and is expected to get underway by the summer.

New water rates now in effect

The charges for water usage in West Baton Rouge changed effective January 1. Most residents will have a slight increase in their water bill of less than \$1 per month. For example, an average home water usage of 6,000 gallons will pay \$19.05 under the new rates, just 50 cents more than the existing rates.

The primary change is a new, simplified rate structure, as follows:
\$8.65 for 0-2,000 gallons (this is a \$1 increase);
\$2.60 per 1,000 gallons for 2,001 to 10,000 gallons; and
.75 cents per 1,000 gallons for over 10,000 gallons of water used.

Commercial rates will be \$25.31 for 0-10,000 gallons used, and
.75 cents per 1,000 gallons for over 10,000 gallons used.

The industrial rate was .60 cents per 1,000 gallons, and will go to .75 per 1,000 gallons.

New training center offers high tech equipment, capabilities

West Baton Rouge Parish deputies now have a new training facility that offers firearm simulator training and other high-tech capabilities to help deputies be as prepared as possible for their difficult job.

The 4,000 square feet facility is located behind the parish jail facility, and includes a large training room with a projection screen for classes, a full kitchen, office and storage rooms, and a state-of-the-art firearm simulator training room.

The new facility was paid in large part by grants and donations by local businesses. "All deputies train for 80 to 100 hours, much more than the required annual training," explained Training Director Tommy Schiro. "We finally have one location where we can offer all of the training, and can keep the records required of the training for each deputy."

The firearm simulator training is new, and is one of few simulator training facilities in this area. It provides more than 4,000 training scenarios played on a huge screen. During the training, deputies are required to make split second decisions on whether to shoot in very volatile and rapidly evolving situations. This specialized training helps deputies be more prepared for these situations in their work.

Computers are set up with internet access for deputies to do other on-line training. "There are constant changes in protocols and technology in law enforcement and this facility enables us to provide the best training possible for our deputies," said Schiro.

"We have already offered our facility and equipment to other local law enforcement agencies and the fire department for their training," said Schiro, who credited Sheriff Mike Cazes with the vision for the facility and pushing for grant funding for construction.



Brusly was one of the first municipalities in this region to offer a bike share program, and it has been very popular with both residents and visitors.

Lee, Hicks and Council take oaths

Mayor Richard Lee, III took the oath for his second term as mayor of Port Allen prior to the City Council's January meeting. He and other officials were sworn in by new District Attorney Tony Clayton.

Corey Hicks was sworn in as Chief of Police, beginning his first term in office. New Council members include Clerice "Clo" Lacy, Council Member at Large; and Charlene Gordon, District 1. Council members beginning another term include Brandon Brown, Garry Hubble, and Hugh Riviere. Brown was appointed by a vote of the Council as Mayor Pro Tem, and Rose Roche was appointed Municipal Clerk by a vote of the council for this term.

Bruce Bass named Employee of Year

The City of Port Allen named Bruce Bass as its Employee of the Year for 2020. His honor was announced at the city's annual awards ceremony in December. Bass is the Roads & Drainage Supervisor for the city, and is in his 28th year as a city employee.

Sewer treatment remains priority for 2021

The location for a new city wastewater treatment plant remains a top priority for the City of Port Allen in 2021, said Mayor Lee. "We are still searching for a site that is suitable for us to connect our line that discharges effluent to the river," he explained. "Our plant is 60 years old, and needs to be re-located out of a residential area," he said.

"We have a number of supervisors who are contemplating retirement in the upcoming years, including roads & drainage, wastewater treatment, water & gas and administration. We need to have a replacement for each one of these positions trained and certified prior to these supervisors leaving," said Mayor Lee.

City gets state award for Centennial Park

The Louisiana Municipal Association presented the City of Port Allen an honorable mention Community Achievement Award for the development of Centennial Park, located adjacent to the Old Ferry Landing and City Hall. The park includes a beautiful pavilion, walking trail and benches. A bathroom facility and exercise equipment with a canopy for shade, totaling approximately \$162,000, will be added to the site in 2021.

WBR tourism gets big grant for advertising

The West Baton Rouge Convention & Visitors Bureau has received a \$77,500 grant for advertising from the Louisiana Office of Tourism, announced Tourism Director Kathy Gautreau.

"The grant must be used for advertising, and there are restrictions about the venues we use to advertise, but we are very pleased to get these funds, especially with the blow that tourism has taken due to the COVID-19 pandemic," said Gautreau. She said the parish will use the grant funds to promote local hotels, shopping, attractions and dining.

KITE FEST RE-SCHEDULED

Kite Fest, which was set for March, has been tentatively rescheduled for May 22 and 23, said Gautreau. "Of course, we will have to see if the state moves out of Phase II and into Phase III of COVID restrictions to make a determination on whether we can hold the event. It is an outdoor event in a very large open area, so that may help some. We will make a determination on the event later this Spring," she noted.

CAPITAL OUTLAY PROJECTS FOR 2021

The visitor and convention center were renovated with new carpeting, flooring and a re-do of the banquet room during 2020, and now the outdoor landscaping will get a re-do too! The landscaping at the facility will be rejuvenated beginning in January. The outdoor area behind the center was significantly upgraded in 2019, when a large new patio area, complete with a pavilion and landscaping, were added.

Gautreau is also planning on having drone footage shot of the building and grounds this year to provide fresh video to promote the facility for events. Presently events of 50 people or less are being allowed, but bookings have been slow due to COVID restrictions.

Special assessments, exemptions available to property owners

Louisiana residents have several special assessments and property tax exemptions for property owners who qualify, said West Baton Rouge Parish Assessor Chris Guerin. The special assessments and exemptions are listed below.

SPECIAL ASSESSMENT FOR BEING AGE 65 or OLDER OR DISABLED:

The Louisiana Special Assessment Level program allows for residents who are either:

- 65 years of age or older, or
- a veteran with a service connected disability rating of 50% or more by the U.S. Department of Veterans Affairs, or
- a person permanently totally disabled as determined by a court or a state or federal agency, or
- a member of the armed forces of the U.S. or Louisiana National Guard who was MIA/KIA /POW

to have the assessed value of their residence frozen for property tax purposes. This means their homes would not be subject to revaluation every four years and the assessed value of their homes would remain the same no matter if property values increase.

To be eligible for any of the Special Assessments property owners must:

- own and occupy a residence qualifying for the homestead exemption, and
- have a combined adjusted gross income of

\$100,000 or less in 2019 or later, and

- present proof of income and personal identification.

EXEMPTION FOR VETERANS DISABLED IN SERVICE:

Veterans with a service-connected disability rating of 100% unemployability or totally disabled by the United States Department of Veteran Affairs are eligible for an increased homestead exemption, constitutionally approved by West Baton Rouge Parish voters in 2011. Veterans who qualify are **eligible for a homestead exemption up to \$150,000** on their owner occupied primary residence. The surviving spouse of a qualifying deceased veteran shall be eligible for the exemption if the surviving spouse occupies and remains the owner of the property, whether or not the exemption was in effect on the property prior to the death of the veteran.

EXEMPTION FOR UNMARRIED SURVIVING SPOUSES OF MILITARY, LAW ENFORCEMENT & FIRE PROTECTION OFFICERS:

Act 678, approved by state voters, became effective December 1, 2016. **Act 678 establishes an exemption from property tax for the total assessed value of the primary residence** for the unmarried surviving spouse of a person who died

while on active duty as a member of the 21 armed forces of the U.S. or the Louisiana National Guard, or while performing their duties as a state police officer, local law enforcement officer or fire protection officer.

EXEMPTION FOR UNMARRIED SURVIVING SPOUSE OF FIRST RESPONDERS:

Act 427, approved by state voters, became effective January 1, 2018. **Act 427 establishes an exemption from property tax for the total assessed value of the primary residence** of an unmarried surviving spouse of a person who died while performing their duties as an emergency medical responder, technician, paramedic or volunteer fire fighter.

Assessor Guerin urges any property owners who qualify to come in and complete their applications for these programs at the Assessor's Office in the West Baton Rouge Parish Courthouse in Port Allen.


