Parish voters asked to renew community center tax in August 15 election

West Baton Rouge Parish voters will be asked to renew the 3 mill property tax to fund maintenance and operation of the parish's six community centers in the August 15 election. Early voting for that election is July 25 through August 8, excluding Sunday. The parish's Recreation Department presently operates the centers across the parish, which include the WBR Community Center, Post 167 American Legion Hall and William & Lee Community Center, all in Port Allen; the Erwinville Community Center, and the Addis Community Center and VFW Hall, both in Addis.

The 3 mill tax renewal will provide approximately \$1.33 million annually for operation of the facilities for 10 years. The 3 mill tax was initially approved by voters in 2001.

"The community centers are vital to our communities as an affordable place to hold gatherings, meetings, church functions, and numerous other events and sports activities, but they are expensive to maintain and operate," noted Parish President Riley "PeeWee" Berthelot. "They really are the lifeblood of our communities and are used daily."

The community centers are used as evacuation shelters and the Addis Community Center houses the WBR Chamber of Commerce. The community centers are also home to a variety of functions including the Safety Town program that teaches kindergartners about safety, kid camps, exercise programs, commodity distributions, graduation parties, the YMCA fund-raiser, school and sports banquets, youth sports and leagues, worker safety training programs, weddings, Mardi Gras balls, high school proms and other activities.

All of the centers have received improvements in recent years, but capital improvements is an on-going cost due to the extensive use of the buildings throughout the year. The parish 2020 budget for the community centers is shown at right.

Approximately 85% of the tax is funded by business and industry, with homeowners funding about \$246,000 of the total collected. A homeowner with a home valued at \$200,000 will pay \$37.50 on the tax, while a home valued at \$300,000 will pay \$67.50 on the tax.

Museum offers lagniappe tours, new exhibits

The West Baton Rouge Museum is open, and has provisions in place for public health protection. Face masks are required to enter, and social distancing is being enforced, both inside and on the Museum grounds.

The Museum 6-acre campus includes walkways winding through gardens, historic buildings sharing regional history, gallery spaces filled with art and artifacts, a juke joint jumping with music and memorabilia, and a demonstration barn displaying a vintage tractor, Model A and antique tools used in many trades and handicrafts.

Walk-in visitors are welcome six days a week, Tuesday – Saturday, 10 am – 4:30 pm, and Sundays, 2 – 5 pm. Admission is \$4 per adult, \$2 per child and senior citizens, and free to residents of West Baton Rouge Parish and members of the West Baton Rouge Historical Association.


Special lagniappe tours can be arranged by making reservations at least a week in advance. Advanced, paid reservations can include one of the following demonstrations to a weekday tour for an additional fee: Spinning and weaving, wash day, woodworking and blacksmithing, or the Early Louisiana Experience showcasing native people and early explorers. The cost for the additional tailored tour experience is an extra \$20 per group.

MUSEUM ACTIVITIES AND EVENTS

• **Cafe Francais** will resume on Aug. 7 at 1 pm with a celebration of Acadian heritage. The monthly program is free. Each meeting features a topic to spur discussion. And, of course, there's always a bit of coffee and a little something sweet to eat.

• **Old Time Music Jam**- The Jam is held on the second Sunday of each month from 3 - 5 pm outdoors, with musicians on the covered porch of the museum's Juke Joint and guests under the shade of sprawling oak trees. Musicians informally play acoustic instruments featuring Old Country, Bluegrass, and folk music. To insure the health and safety of all, musicians and visitors alike should bring their own lawn chairs, masks, and refreshments.

• **Burny Myrick's The Timeless River**- A reception in celebration of the exhibit Burny Myrick's The Timeless River is set for Sunday, August 30 from 2 – 4 pm. It features drawings and paintings depicting life and work along the Mississippi River from 1850 to 1900 during the great steamboat age. Born in Mississippi, Myrick first sketched the Mississippi River



in the late 1930s. He developed a love of the river and focused his art on the people and places that thrived on the waterway.

• **The Collectable Life of Mignon Faget** –This exhibit opens on Saturday, August 1, with a FREE reception from 6 – 8 pm, complete with a gallery talk with guest curator Nolde Alexius. It will be on display through January 3, 2021. Faget's close observation of the natural world, particularly the Gulf Coast, as well as her native New Orleans, forged her iconic style.

• **COVID Essay Contest**- Middle and high school students are invited to put their research and writing skills to practice by writing a 300-word essay on what they are doing during COVID 19 social distancing. One student from each level will win. Entries are due by September 7, and the winners will be announced the last week of September. A virtual exhibit will be developed to share participants' artwork, photographs, videos, poems, songs, journal entries, or other creative activities.

• **Blues After School**- The program will continue in the coming school year. A few spaces are available for West Baton Rouge middle school students interested in learning music. Participants will meet four times a month after school from September – April for this free 2-hour music program with music educators from Rockin' Mozart Academy, museum staff, and special guests, who will share the rich culture and tradition of Blues music that has deep roots in West Baton Rouge Parish.

Mosquito spraying ramped up, testing positive for West Nile

Mosquito control is in full force in West Baton Rouge, with spraying on a daily basis. However, some mosquitos caught in trapping for samples have tested positive for West Nile virus.

"This is typical around this time," said George Bragg, Mosquito Control Director. "We see West Nile activity increase in July and August, and then begin to taper off in late September or October."

Mosquito larvicide tablets are available for pickup at the Mosquito Control office, 3147 Ted Denstel Rd., Port Allen. They are free to the public and one pack per residence is issued.

Residents are urged to do their part to stay safe from mosquitos by following these precautions:

- When possible wear long, light colored, and loose-fitting clothes
- Use mosquito repellent with the active ingredient DEET or Picaridin in a 15% to 20% concentration.
- Avoid being outside or use repellent during the hours of dusk and dawn, when mosquitos are most active.
- Flush out bird baths once a week; drill a large hole in or dispose of old tires so they don't collect water; stock ponds with fish or install a fountain, regularly empty kiddie pools and maintain swimming pools.
- Make sure window and door screens don't have holes.
- Seal cracks around window air conditioning units.

If anyone has questions or concerns about mosquito control, call 225-214-5900, leave a message, and the phone call will be returned.

New water line complete to Brusly, next phase is extention to Addis

The parish's major water project to increase water flow and pressure in the southern part of the parish is partially complete. A new 20-inch water main from Northline Road to W. St. Francis Street, and the 8-inch gas main from Northline Road to Riverside Drive are both now in service. While the mains are in service, the contractors are still on sight finishing up the project.

The water main from the new water well located at the Louis Mouch Multuse Arena to the water line that currently crosses the Intracoastal Waterway, is being installed and is expected to be complete by the end of September.

The parish opened bids in mid-July for the extension of the water main from W. St. Francis Street in Brusly to Addis. Once the contract is awarded, this project is expected to take approximately 240 days.

In addition, the parish is currently upgrading a 2-inch water main to an 8-inch water main from just south of Parker Lane to the Addis water tower. That project is almost complete.

Once all of these phases are completed, water will then travel from north of the Intracoastal on Court Street to the water tower on First Street in Addis.

A future project being planned by the parish is upgrading the water main on Andre Lane, Maxine Street and Nolan David Road.

Road improvements underway

The parish's \$1.6 million road improvement program for 2020 is now underway. Roads being overlayed include: Riverside, Mardell, Marlene, Toni, and Cassandra Drive, Joey, Gail, Andrea, Michelle, Deanna, and Tara Avenue, McLin Road, Maple Street, the Lukeville Lane extension, Rue Riviere and Iris Drive, Country Club Road, and Loupe Lane.

In addition, repairs continue to be made to Commercial Drive and South Westport Drive. Finally, the parish is in design on the La. Hwy. 415 Connector, and Rosedale Road is being reconstructed.

WBR Fire Department makes push for volunteers in community outreach

The West Baton Rouge Parish Fire Department is making a big push in communities to educate residents on fire safety, and to ask for volunteers. The department has about 62 volunteers, said Fire Chief Tim Crockett. It relies greatly on volunteers, with only 18 full-time firefighters.

"We need volunteers to help with many activities," said Crockett. "They don't need to suit up as a firefighter. We need people to maintain safety and provide water at an emergency scene, and to handle projects at fire stations. We will train the volunteers in CPR, first aid skills, and firefighting." Sheriff's Office works to maintain positive relationships

Sheriff Mike Cazes recognized long ago that strong relationships and mutual trust between law enforcement and the community is critical to maintaining public safety and effective law enforcement. In the wake of the protests nationwide regarding police use of force and other issues, Sheriff Cazes has stepped up Sheriff's Office communication with residents and reinforced proper arrest procedures among deputies.

"We already had diversity training for our deputies, and will continue listening to community concerns," said Sheriff Cazes. "In West Baton Rouge, people work together for the betterment of everyone, and we want that to continue. I welcome any resident with concerns and will make sure the Sheriff's Office is visible and active in the community."

Uptick in vehicle thefts seen

Residents are advised to remove all valuable items from their vehicles and lock them, as vehicle theft has been on the rise. The Sheriff's Office has increased patrols to deter these activities, but residents should be pro-active in protecting their property by not leaving items inside unlocked vehicles, where they are easily accessible.

Hurricane season is well underway, and residents are advised to plan early for the potential of having to evacuate, or the possibility of flooding and/or severe weather that would result in power outages.

Fall concerts on hold, projects continue for town

The Town of Addis cancelled two of its Live At Five on the Westside concerts in the Spring, and Mayor David Toups said the fall concert series is also on hold for now. "Our first concert was set for October 23, but we are waiting to see if the state moves past Phase 2 of the COVID 19 re-opening plan. If that doesn't happen by early fall, then it is unlikely we will hold the events," said Toups. "The recent increase in cases doesn't help."

MAJOR SEWER PROJECT TO BE COMPLETED BY FALL

A major sewer improvement program that includes running a pipeline from the pumping station serving the Sugar Mill development and the YMCA directly to the town's wastewater treatment plant should be complete by this fall. The project will provide several benefits by moving the wastewater directly from that pumping station to the plant. Pressure will be taken off the sewer system in that area, it will lessen maintenance on the pumping station and system, and the wastewater system will operate more efficiently.

ROAD OVERLAY PROJECT TO BEGIN IN SEPTEMBER

The town's 2020 road improvement project is expected to begin in September. Mayor Toups said roads throughout town will be milled and overlaid in the \$450,000 project. The town sets aside funds annually for road improvements.

Meanwhile, work on new residential developments continue. The 19th filing of Sugar Mill, including both apartments and homes, is underway; and the infrastructure work on Cane Ridge Subdivision between La. Hwy. 1 and the Mississippi River is also underway. That development will include 55 home sites.

New police body cameras provide state-of-art features

Brusly police officers will have new state-of-the-art body and vehicle cameras by August that will provide not only increased protection for officers, but also greater transparency in officer interactions with the public.

The Brusly Town Council approved the funds for the cameras to be paid over a three-year period. The old cameras had to be activated. The new cameras begin recording automatically in numerous situations, and have many other features the old cameras did not, including:

- Officer down emergency alerts - If an officer goes down and does not respond, the camera automatically starts recording, and sends an emergency alert to the dispatch center, supervisors and nearby officers.
- Gunshot protection - The camera automatically starts recording when a gunshot sound is detected. In addition, the camera also detects when the officer removes his firearm from the holster and immediately starts recording. It also notifies dispatch and nearby officers.
- Video live streaming and immediate review - Central dispatch can start live video streaming from any camera or the in-car camera system. All video is uploaded to secure storage, and is available immediately.
- Secure camera mounting - The camera has a secure mounting system, but if it is jarred, central dispatch is notified.
- Better car video views - The in-car monitor documents interactions at traffic stops and other street-related incidents using combined front and rear facing cameras with audio.

"This system provides increased safety and protection for our officers, and also provides protection to the public when there is a question about how a matter was handled," noted Mayor Scot Rhodes.



One of the features of the new body cameras is that they automatically record and alert dispatch and other officers when an officer pulls a gun from the holster.

Sewer, road projects complete, park improvements coming

A sewer improvement project and the road overlay program for 2020 have both recently been completed.

A \$375,000 project to move, deepen and enlarge the sewer lift station, deepen it and re-route a larger sewer line to the treatment plant has all been completed in the Westside Village subdivision. The project will alleviate back-ups in the subdivision during heavy rains, and is part of a comprehensive sewer improvement program that has been underway for several years.

The city's annual road overlay program is also complete, and included Melissa, Maryland and Georgia Avenues. The city budgets \$300,000 or more annually for road repairs and overlays.

The city has received a \$50,000 grant for repairs to deteriorating water pipelines on Maryland Avenue between 10th and 12th Streets and to 8th Street between California Avenue and Maryland Avenue. That project will be underway next year.

Restrooms coming for parks

The city has just issued a contract for the construction of a restroom facility at both Cohn and Centennial Parks. The buildings will include a men's restroom and a women's restroom, and each building will cost approximately \$75,000. "We have a lot of residents who use our parks, and having a restroom facility there makes our parks more convenient and appealing," said Mayor Richard Lee.

Benches, lighting for trail



WBR tourism re-focuses on 'staycation' advertising

Gautreau is not sure if the Oldies Fest, which was planned for September 13th this year will happen. There is a chance it may have to be cancelled. "We are hoping we will still be able to host the Smokin' Oldies State Championship BBQ Contest on September 12th. Please visit our website & Facebook page for updates on the Festival and BBQ Cook Off," she said.

"We have transitioned our advertising to staycation ads, promoting spending time in West Baton Rouge, enjoying all the things to do and see here and in our nearby region while staying in one of our many hotels," she said. One of the ads is shown at the right.

"Louisiana has been tested time and time again, but a resilient tourism industry has been able to bounce back stronger than ever each time," Gautreau concluded.

Info released on state small business recovery program

State Treasurer John Schroder's office has released new information about Louisiana's Main Street Recovery program, the \$300 million small business relief fund created by the Legislature during the regular session.

To be eligible for the program, businesses must meet the following requirements:

- Were domiciled in Louisiana as of March 1, 2020
- Suffered an interruption of business
- At least 50 percent owned by one or more Louisiana residents
- Filed Louisiana taxes in 2018 or 2019 or will file taxes in 2020.
- Had no more than 50 full-time employees as of March 1, 2020
- Have customers or employees visit a physical location
- Are not part of a bigger business with more than 50 full-time workers
- Does not exist for the purpose of advancing partisan political activity and does not directly lobby federal or state officials
- Does not derive income from passive investments without active participation in business operations

RE-VALUATION 2020: What should property owners expect?

The West Baton Rouge Parish Assessor's Office is currently wrapping up work on its 2020 quadrennial re-valuation, as mandated by Louisiana Constitution Article VII, Sect. 18(f) and Louisiana R.S. 47:2331.

With property values remaining strong across the entire parish, many property owners should expect to see increases in value with some property owners seeing substantial increases in value.

In light of the expected property value increases, for 2020 the Assessor's Office will forgo its entire 2.47 millage normally collected annually to fund office operations.

Additionally the Assessor's Office is giving consideration to one-time value reductions in 2020 for all residential and commercial real estate owners, as well as business personal property accounts, due to economic hardships brought on by the COVID 19 pandemic.

Assessor Barney "Frog" Altazan stated, "Our office is in control of a very small fraction of the property tax rate in West Baton Rouge Parish. In six of the last twelve years, 2008 – 2019, our office has opted to take a reduced millage to fund our office operations. **In doing so, we have saved property owners approximately \$2.7 million dollars. By forgoing our entire millage for 2020 and using surplus funds to operate the office, we will be saving**

residential and commercial property owners approximately \$1.3 million dollars."

Assessor Altazan further stated the Assessor's Office has no control or influence over the millage rates ultimately levied by other taxing jurisdictions in the parish.

In regards to the possible one-time value reductions, Assessor Altazan stated, "Louisiana R.S. 47:1978.1 pertains to a Governor declared emergency and the affect it may have on property values. We feel this statute affords our office some degree of discretion to consider one-time value

reductions brought on by COVID 19 economic hardships."

The Assessor's Office, in accordance with Louisiana R.S.47:1987, will be mailing out Notifications of Value (NOV's) to all property owners who will see an increase in value due to the 2020 quadrennial re-valuation. NOV's should be in the mail to all affected property owners by the end of August. Also of note, the Assessor's Office open book review period will run from September 1st through September 15th.

Assessor Altazan also wants to remind property owners there is still time, before new values are locked in, to apply for homestead exemptions and special assessments, such as the over age 65 freeze and the veterans preference for a service-connected disability.

EXPANDING RAIL SERVICES



A \$22 million railcar chambering yard is under construction on Port property located on the Intracoastal Waterway. The project will expedite rail delivery of wood pellets to Drax Biomass, with the potential of expanding rail service to the Louis Dreyfus grain elevator.

Helping substantially to revitalize Louisiana's timber industry, Drax Biomass has pledged proceeds from additional pellet shipments as a match for state and Port funding. Anticipated demand for the chambering yard has grown significantly since the project's inception as Drax Biomass has expanded from one operating pellet mill to three mills.

"This rail service expansion will also make the Port a more attractive site to prospective new tenants," said Port Executive Director Jay Hardman. "It's a great public/private project made possible through the combined efforts of the state, Port Commission and Port stakeholders."

WBR public schools re-opening information

WBR school re-opening under COVID Re-opening PHASE II:

- Grades Headstart-6
 - Students in these grades will attend school In-person.
 - Static groups will be maintained to the extent possible.
 - Students in grade 3-6 will wear a face covering to the extent possible.
- Grades 7-12
 - Students enrolled to attend school in-person will follow an alternate schedule on campus.
 - We will have two groups separated by last name.
 - Approximately 50% of the students in grades 7-12 will be in a group that attends school on campus each day.
 - Example - Group A attends Monday, Wednesday and every other Friday. Group B attends Tuesday, Thursday, and every other Friday.

WBR VIRTUAL ACADEMY - Students will not be on campus and will receive teacher led virtual instruction daily. Students must enroll in the Virtual Academy and classes will be made up of students district-wide. Deadline is July 24. Students must be enrolled in a WBR school.

DISTANCE LEARNING - Teacher led virtual instruction with students off campus when there is a school closure and for our alternating schedule.

PHASE III:

- All students will attend school in-person.
- Students enrolled in the WBR Virtual Academy will remain in that platform.
- Safety protocols below will be followed.

How we are re-opening safely:

1. Temperatures will be checked for adults and students upon arrival or entering building.

- Adults and students with a temperature of 100.4 or higher will be evaluated by the school nurse to confirm the temperature reading is accurate and check for other symptoms.
- Students with a confirmed temperature of 100.4 or higher will be isolated until a parent picks them up.
- If the school nurse confirms an inaccurate temperature reading and there are no other symptoms of an infectious disease, the student will be allowed to return to class, and adults will return to their duties.

2. Hand sanitizer will be provided at the entrance to every class.

- Students will be allowed to wash their hands regularly and/or have access to hand sanitizer to the extent possible.
- Hand washing / sanitizers will occur a minimum of three times a day.

3. Social distancing guidelines will be followed to the maximum extent possible.

- Gatherings of students at entry and exit points will be monitored and minimized.
- Desks will be spaced apart to the maximum extent possible in classrooms.
- Students will remain six feet apart during transitions to extent possible.
- Elementary students will stay in static groups to the extent possible.
- Meals will be provided with social distancing, students will be six feet apart in the cafeteria to the extent possible.

4. Wearing a Face Covering

- All students will be given the option to wear a face covering.
- Students in grades Headstart - 2 will not be required to wear face covering.
- Students in grades 3-12 will be required to wear a face covering to the extent possible.

- All employees will be required to wear a face covering to the extent possible.

5. Stay home if you are sick.

- Parents will be encouraged to keep their children home if they are sick.
- Schools will monitor students for symptoms of illness and will contact parents to come pick them up.
- All employees will be sent home if they show signs of illness.

6. Facilities will be sanitized to the maximum extent possible

- Students will be given a disinfectant wipe to wipe down their desks when they enter class and when they leave.
- High-touch surface areas will be wiped down by school employees regularly.

What do we do if a student or employee is exposed or tests positive?

We have guidelines in place that are based on guidance from our Regional Medical Director. Medical professionals will determine who needs to be quarantined and/or who needs to be tested.

- Schools will not be required to close if someone tests positive. We will follow the guidance of medical professionals.
- Parents will be notified if there is a confirmed positive test for any student or staff member at a school.
- Students and employees exhibiting COVID-19 symptoms can be required to get a medical release and/or to be tested before being allowed back on campus.

Transportation

Transportation will be provided for as many students as possible in accordance with the DOH Guidelines for Phase II and Phase III.

UPDATE: School construction projects winding down

Brusly High School (new school) – The main building was turned over to the staff to move in on July 22. The contractor is working on finishing touches and landscaping. The gym building and the field house are nearing completion.

Brusly Middle School (old high school) – The building is getting new ceilings, lighting, paint, restrooms and CAT 6A computer wiring. Completion scheduled July 31. Renovation of the wrestling building will be complete in October.

Brusly Upper Elementary School (old middle school) – New ceilings, lighting, paint, CAT 6A computer wiring, restrooms, playground equipment decorative fencing, and exterior paint. The project to be complete by July 31.

Port Allen Middle School – Exterior paint and new windows, ceilings, lighting, flooring, paint, CAT 6A computer wiring and roof. Substantial completion scheduled by July 27.
